The approach is one of 'challenge and response,' whereby questions of constitutional importance are posed and the reader is then led, by engaging with primary and secondary materials, through how the various Asian States respond to these questions and challenges. Chapter segments are accompanied by notes, comments, and questions to facilitate critical and comparative analysis, as well as recommendations for further reading. The book presents a representative range of materials from the following States: China, Japan, Mongolia, Taiwan, South Korea, Hong Kong, the 10 ASEAN States, Timor-Leste, India, Pakistan, Bangladesh, Sri Lanka, and Nepal.
